Nestor brought up the issue with the house on North 106th Circle. We are going to send them a notice that their improvement has not completed within 1 year. Their latest extension with the court runs out on July 31st, so we are going to talk about foreclosure on this house in the August meeting. Sandi made a motion to accept. Election Committee Report.

The only person that ran for board position was Brian, and he was voted in. The meeting for the officers followed a

week later. Nestor retains his position as president. Brian retains position as vice-president and secretary. Sandi has taken over treasurer. Brian made a motion to accept. Sandi seconded. **Report Accepted.**

Grounds Report.

Kory prepared a report, and Nestor read the report in his absence. All weeds have been sprayed on all entrances and islands. He also cut back and shaped the bushes at 106th and Reddick. The tree near 105th and Ida was removed by Nestor, Kory, Brian and Kim. The tree near 103rd and Ida was cleaned up after the storm by Kory, Brian and Kim. Sandi made a motion to accept. Brian seconded. **Report Accepted.**

Treasurer's Report

There is currently \$40,005.75 in checking. Our current outstanding A/R is \$7,540.06. Brian made a motion to accept. Sandi seconded. **Report Accepted.**

Covenant Report

Brian gave the report for May. We had discussion about the trash collector. His siding is still not finished. We also noted that he has a trailer that has been there more than 20 days, which exceed what the covenants allow. Sandi made a motion to accept. Brian seconded. **Report Accepted.**

Mayors hotline has old outdated information about the association. Brian will work to get this current.

Sandi brought up the welcome packets so we can discuss what can be removed.

Eldon asked how we are going to present liens on the website notification. Nestor will ask Curzon how to do this.

Eldon asked where we are with bookkeeper. Nestor said this was delayed due to annual elections, but Sandi will get this back in action now that she is treasurer.
