Treasurer's Report

There is currently \$53,429.02 in checking. There is \$4,660.94 in A/R. The bulk of the balances are carried by only a few home owners. Sandi confirmed that there are liens on every home owner over \$100. We also discussed the process of foreclosure to be sure we didn't miss anything this year. Brian made a note that the first time we foreclosed on a 'dues lien', that the attorney fees far exceeded what we collected, and we had to write off the home owners balance. We need to make sure we don't get into that off-balance situation again.

Brian suggested change the \$100 a year covenant penalty, to something more substantial. We have several residents who feel the \$100 a year is a 'permission to violate covenants'. Brian suggested \$500 or \$1000 a year to make it something that grabs their attention.

Sandi presented the bill for Jean's services.

Eldon made a motion to accept. Brian seconded. Report Accepted.

Covenant Report

Brian gave the report for May. Brian expressed concerns that we have some violations that we cannot resolve because the home owner refuses to work with us.

Eldon made a motion to approve. Sandi seconded. Report Accepted.

Sandi and Dave went down to Ida and cut the grass and cleaned up the area. Sandi is concerned that we hired someone to do this, and it was in such poor shape. Eldon asked where we are with replacing the fence.
