### **Old Business**

Kory brought up concerns about the cables that are laying along the fence, and all of the open boxes along the fence. It looks trashy, and needs to be addressed. Kory is going to talk to the planning department to get a map of who owns which box along Military.

#### **New Business**

Brian brought up the issue with the poor maintenance of the fence along the West side. We have always believed this fence belongs to 'The Bluffs at Cherry Hills'. We talked about how to address getting this fence repaired. Brian took it as a 'to do' to follow up on this.

Kory made a motion to get a bid from Big Red to finish those islands. Sandi seconded. **Motion Accepted.**Brian made a motion that if it's less than \$750, Kory doesn't need approval. Sandi seconded. **Motion Accepted.**Sandi asked about insurance on the fence.
