Greetings to all from the Covenant Committee. We have had a busy year. We have had a successful year, in that we have seen several long term covenant violations corrected. We work constantly with homeowners to correct violations, however, there are some violations that require large financial outlays and long term planning. There are also a few homeowners who don't see the need to cooperate with the rest of their neighbors. These homeowners need a little more forceful encouragement.

This year we have also seen a great many improvements. New windows, new siding, fresh paint, new decks, new roofs, updated landscaping, and new driveways are some of the major improvements that we have seen in the neighborhood this year. Congratulations to all of you making these improvements. We, your neighbors, thank you.

Spring will be here before we know it. Now is a good time to plan the improvements your home needs and that you want to make. PLEASE REMEMBER THAT ALL IMPROVEMENTS TO THE OUTSIDE OF YOUR HOME MUST BE SUBMITTED TO THE HOMEOWNER'S ASSOCIATION FOR APPROVAL. The covenants state "An owner desiring to erect an improvement shall deliver two sets of construction plans and plot plans to Declarant" "Such

plans shall include a description, type, quality, color and use of materials proposed for the exterior of such improvement." Declarant is the Homeowner's Association. The reason for this is clear, improvements must adhere to the requirements of the covenants. IMPORTANT, PLEASE SUBMIT YOUR PLANS FAR ENOUGH IN ADVANCE OF THE START OF WORK. Don't expect the board to approve a project a day or two before work is started. Allow at least two or three weeks for approval. Send complete information.

Our thanks to all of the cooperative and respectful homeowners of Cherry Hills you make our neighborhood a fine place to live.



Winter is not over yet! We don't know if any damage to plants, bushes, trees or fence will occur until spring comes. As always we perform a fence inspection and repair or replace as needed. This spring we will put down mulch and replace trees and bushes as needed. Please do not allow unplanned trees to grow along the fence. As they grow, they seriously damage our perimeter fence. Our covenants and bilaws provides that any damage due to resident's neglect will be repaired at their expense. Please do your part. Keep tree branches off of the fence and remove any growth under and around it. Last year, rain and storms caused additional damage to our fence and also caused delays in repairs. As always we strive to perform any repairs to the fence as quickly as time and weather will allow. We hope the weather will be kinder to us this coming year.

## Delinquent home owners!

Starting in 2016, we will be enlisting the help of a collection agency to go after homeowner's who do not feel a need to pay their dues.

If you received a red notice in your annual dues with an 'URGENT' stamp on the envelope, then you are in danger of being on this list.

At this time, we are discussing procedures with a few different collection agencies.

#### **Lien Process**

Effective 1/1/2014 the board changed Covenant violation liens from a one time \$75 fee to a yearly \$100 fee.

The board is legally bound with the duty to enforce the covenants. If a resident ignores our efforts to enforce the covenants we are duty bound to enact policies to encourage compliance.

Recently homeowners in Cherry Hills received a mailer from CBS real estate agent Dave Coover. The mailer had a lot of interesting information about Cherry Hills. This information is important and bears repeating for those who might have missed it. A few interesting points.

From Dave's mailer: "Your average return is 13.4%. Homes sold in Cherry Hills averaged a return on investment (ROI) of \$23,500 from 2013-2015. Compare that to the US average savings account return of 0.12% on balances over \$100,000!"

Also from Dave's mailer: "A strong Homeowner's Association protects home value: Real estate research has shown over and over again that areas with a strong homeowner's association provide the best home ROI. Attractive entrances, tidy homes and wellmaintained common areas are key features that new buyers look for when investing in real estate."

We, your homeowner's association board, understand the truth of these statements. These are statements of fact. We know that most of the homeowners of Cherry Hills also understand. All but a few of the homeowners are thankful and cooperative and we, the board, want to thank you for all of your cooperation. 
Trash Cans and Yard Waste Trash cans and yard waste containers must be stored where they are not visible from the street. ATEMPTING TO HIDE TRASH CANS BEHINDE A BUSH IS NOT ACCEPTABLE. Most of our





homeowners are very good about this, however, there are a few who refuse to cooperate. Remember, there is also a city ordinance that covers this violation and it carries a hefty fine.









**Pools** Above ground pools over one foot high are not allowed.



Trailers, Boats and Campers These items may not be stored on a property for more than 20 day in a calendar year. The covenants also prohibit parking construction equipment in the neighborhood.



Yard Mowing and Upkeep Yard mowing must be done on a regular basis. Yards must also be kept relatively weed free.



Dead Trees and Bushes Please make plans to remove any dead trees and bushes on your property. Dead trees on a property are unsightly but can also be dangerous.

Update from the David Hansen, NW Tri "C" Omaha Coalition Citizens Patrol Captain ~ (Cherry Hills. Cherry Ridge & Crown Point)

With the weather turning nicer, burglaries are on the rise. Suspicious vehicles roaming the area or individuals walking the area are possible signs of something's up! When patrolling, either driving or walking, we continue to noticed a lot of garage doors open and some past 10: PM. Temptation for theft including vehicles warming up in the AM. It's not spring yet, but soon. This past month we had two neighbor's leave the garage door open after heading to work. We did leave a note and closed. They were very thankful. So please keep an eye on your neighbor's home as they will do the same for you. The hot vehicles being stolen continue to be the older Hondas, Chevy and Dodge Trucks.

Remember that OCCP, "Omaha Collation Citizens Patrol" is the eyes and ears for the police department. They cannot be everywhere. If you see something suspicious, do not hesitate to call 911. Please help us in helping the police department. Your Cell phone is a great tool and can be used in a positive way. Practice the, "what if" for your own safety and when contacting police, taking quick pictures, video, recordings and knowing how to use your cell phone quickly in an emergency especially.

Omaha Collation Citizens Patrol has PAC Meetings every 2<sup>nd</sup> Tuesday of the month from 6:PM – 7:PM at the local NW Police Precinct, 10245 Wiesman Drive, located just south of Cherry Hills and the Post Office or (North of Fort on 103<sup>rd</sup> & Wiesman). Meetings are open to the public and Captain Marcia West will go over the reports and activities from the previous month. It is always interesting to hear how the criminal mind works.

You are not committed to join when riding along, but will allow us to discuss what we have learned about our surroundings on a daily bases.
