### Covenant's Corner

Your Covenant Committee has had a very active year. This year we took action on 101 situations. What does that mean? That means we advised homeowners that they were in violation of the covenants, we approved improvement requests, we worked with the City Code Enforcement Office to bring properties up to code. We also worked with the other committees of the Association to help the Board run more efficiently.

Trash collection was upset this year when the City chose our neighborhood to test a new system. All of a sudden, we were faced with using huge garbage cans and a new collection schedule.

Due to the confusion and temporary nature of this test, the Board decided that we would not press the issue that this caused with our covenants. However, the test is supposed to end in April. We have no information about what the city will do. We do believe that the covenant which mandates that all trash cans be stored completely "out

It is, therefore, our intention to vigorously TRASH CANS-TRASH CANS-TRASH CANS enforce the "out of site" storage of trash cans beginning May 1, 2017.

Dear Homeowners,

It is that time of the year in which the Homeowner's Association renews the contracts for the winter/summer grounds maintenance. As I was recently voted by the board to take over the duties of grounds maintenance, I have been going through the last few years' worth of contracts and contacting prospective contractors for estimates. As the grounds maintenance costs are almost 60 percent of the total Homeowner's Association expenses (and puts us in danger of exceeding our projected budget),

I have been trying to think of ways to defray some of the costs. To say the least, it has been an eye opener. One of our biggest costs last year was the repair of the perimeter fence due to severe weather. Since 2010, the cost of fence repairs has increased 300%. We have already taken some steps to reduce this cost, such as doing minor repairs ourselves and purchasing the post brackets ourselves for the contractor to use. As such, I have also contacted seven contractors to provide us a bid on taking over the repair costs. Unfortunately, only three contractors would entertain taking on this kind of work. It seems that we are a small fish in a large pond. I have also taken the steps of reworking the contracts for the mowing, fertilization, weed control, snow removal. and tree care of the ten islands and common areas outside the fence. We have been able to reduce this cost by \$400 dollars. However, that still does not significantly reduce our costs. We do have a couple of options, if the neighborhood is able and willing to pitch in. One idea is to have one or more homeowners "adopt-an-island". If one or more neighbors would be willing to take on the normal care, cleaning and de-weeding of the nine islands, we could reduce the current cost by another \$400. A second idea/option is for members of the neighborhood to voluntarily remove the snow off the sidewalks along Ida and Military. This would save the Association another \$200 dollars per removal. As a special note, a wonderful neighbor who still remains anonymous, has cleared the snow after the last two snow falls. This has already saved us \$300. On another note, the CHOA renewed its rightof-way agreement with the City of Omaha

and requested reimbursement for the mowing of the common area outside the perimeter fence. This will provide the CHOA a reimbursement of about \$1,000 from the city for taking care of this area.

And lastly, last season, the fence company we contract for repairs advised us that the perimeter fence would most likely need to be replaced within the next couple of years. The current fence is the original fence and has had numerous repairs and parts replaced. The last repair completed (in summer 2016) cost the CHOA almost \$11,000. This was almost a 300% increase for like repairs made in 2010. Both labor and material costs have increased significantly in the seven years. We are currently pursuing proposals from other companies as well as researching the cost to completely replace the fence with either wood or synthetic material. We hope to have all the information available to discuss during the annual meeting in May 2017.

I will be presenting some options to the board for their consideration in the near future. However, if anyone has any ideas, please present them either via the CHOA phone line or email us. I would love to hear your ideas.

#### From the Treasurer

Thank you to all the homeowners that have paid their Homeowner's Association dues/statements! All payments postmarked by February 15th were on time! For any payments postmarked February 16th and thereafter, will be assessed a 15% late fee on the balance owed. Also, any covenant violations that have not been paid and violation rectified, will have another annual penalty fee of \$100 added to the balance. As a reminder, effective 1/1/2014, the board changed covenant violation liens from a onetime \$75 fee to an annual \$100 fee. The board is legally bound with the duty to enforce the covenants and to enact policies to encourage enforcement. Once all the fees have been tabulated, new statements will be mailed. Please submit your payment to avoid further penalties.

Every homeowner is encouraged to come to the monthly Board meetings to be better informed of all aspects of the neighborhood and the Association business. One of the topics of discussion this year, will be whether to increase annual dues in order to fulfill the needs of the neighborhood. The cost of maintaining landscaping, common ground, fences and legal fees have continued to increase throughout the years, therefore, discussion to increase annual dues is becoming a priority. Unfortunately, those who choose to ignore their bill and not pay their "fair share", effects us all.



#### Adopt-an-Island/Sidewalk





This program is designed to allow homeowners to take pride and ownership for the appearance and beautification of the Cherry Hills common areas in and around their homes. This program is intended to provide limited compensation to the homeowners for their efforts, while reducing contractor costs for the maintenance of these areas.



One of more homeowners can adopt-an-island or entrance



Homeowner(s) should coordinate efforts if adopting the same island/entrance.



Homeowner(s) adopting-an-island or entrance will be responsible for the watering, care of trees, shrubs, ornamental bushes, fertilization, weeding, and the general care of the island.




Homeowner(s) participating in this program must provide the CHOA board a point-of-contact or designated representative, if more than one homeowner is caring for an island or entrance.



Homeowners must obtain approval from the CHOA board prior to making any significant changes to the island structure or appearance. Requests for significant changes must be provided to the board in writing prior to the changes taking place.







The CHOA board may credit the designated homeowner (one per island/entrance) for their next years HOA dues, if the upkeep of the island/entrance has met the boards approval throughout the full year.



The CHOA cannot reimburse the homeowner(s) for any expense occurred.
