Covenant's Corner

The covenant's committee has been busy, trying to upkeep the enforcement of the covenants.

Often it may seem like resolution is not happening in cases of violations, but the process takes time. After you notify us of a violation, it may take several months for the process to be completed.

In severe cases of a covenant violation, the board has taken home owners to court to force compliance, and in every case so far, the board prevailed.

This is not always an enjoyable task, but Over the calendar year of 2019, we only one we are legally obligated to take on. Quite often people think we are 'picking on them', but we enforce all covenants fairly and equally.

We never police the neighborhood, all of our actions are based on neighbors calling in to report violations. If you see violations, please report them.

We have a variety of things we do to enforce the covenants. We always start with a friendly reminder letter, letting people know of the obligations of the covenants. We give ample time for residents to resolve the violation. If they refuse to comply, then we have no choice but to apply a lien.

had to apply 2 liens, so thanks to everyone for complying.

We do involve Omaha city code enforcement in many of our proceedings.

Please do your part to help keep our neighborhood looking nice.

Want to join the team?

Please volunteer to be part of the board or just an assistant. If you are interested in serving our community, we have a need for helpers. Please assist us in keeping our covenants in force and our common areas looking nice.

You don't have to be full time, just one or two days a year can make a difference.

Ground's Committee

The ground's committee is in charge of taking care of all of the common areas in the neighborhood, including the entrances. We walk the fence line numerous times each year looking for damage or weak points. When we find them, we try to have them repaired within 30 days, but if we miss something, please feel free to contact us. One thing we have noticed in walking the fence, is that several home owners have trees with branches that are beating against the fence. Please watch for this, and trim your trees. You could be held liable for damages for not trimming back trees, weeds, shrubs, et al. In 2018 we transferred control of the snow removal to the city. This has saved us \$400 or more in snow removal fees per year. For complaints on snow removal, you must now contact the mayors office.



Every other year we bid out contracts for mowing, fertilizing, and tree maintenance. We try to sign 2 year contracts to receive discounts on service. Our current vendors are as follows: Fence Repair: Tom & Ron's repair, Mowing: Big Red Mowing, Fertilizing: Heartland Lawns, and Tree Care: Mutchie Tree Service.

In 2019, we have completed our project to remove all of the juniper bushes from the entrances. We replaced them with more esthetically pleasing plants. All of this was performed by Yard Market and has a I year warranty.

Annual Garage Sale

After much feedback from the neighborhood, we will be moving the garage sale dates to after Memorial Day. Mark your calendars for Thursday June 4th, Friday June 5th, and Saturday June 6th.

The annual sale attracts numerous bargain hunters to our neighborhood. Clean out your closets, garages and storage units. We will be adding signage to busy intersections outside the neighborhood. We will also be advertising the event in advance and during the days of the event. You can participate in any or all days. Let us know if you have any questions.

From the Treasurer

Greetings from your CherryHills Treasurer.

To those that have paid your 2020 Annual dues, we thank you. We still have 67 Homeowners that have not paid. We have 7 Homeowners that have not paid for two years and 8 homeowners with liens on their homes for nonpayment. We have started proceedings for foreclosure on a lien for one home owner. It is important you get your dues taken care of as we will take action. It's only fair to those residents that pay their dues timely.

You talked and we listened-some of you have made suggestions to the invoices/statements and we will be implementing them soon. It's also time that you send any updated email addresses for billing purposes. We

Statements have been going out every month, so it's important for you to know that I pick up checks once a week and they are normally deposited the Monday or Tuesday following. It's possible that those statements may cross in the Mail. If you are inquiring, please be patient. My position is volunteer and I work a 45+ hour week and more besides this volunteer position.

OCCP Omaha Coalition of Citizens Patrol

Please be aware of suspicious vehicles roaming the area or individuals that you do not recognize. Vehicles without license plates and/or parked on public property is not a good indication. If you see a vehicle without a license plate and parked on public property, the OPD ask that you contact 911. Let them know that a "Suspicious Vehicle" is in the area with no license plates. Provide a description and location. Sixteen vehicles were towed away without license plates in our patrol area in 2019.

Recording Serial #'s Please remember to record the serial number of any new purchases should a theft ever occur, or take pictures for your records. For property recovery, "the victims of a burglary that have recorded your serial numbers and reported to OPD can cross-check if the thieves pawned the valuables."

Serial #'s Entered In National Database Using serial numbers of stolen goods, Omaha Police enters the information into a pawn program called LeadsOnline.com, described as the nation's largest online database "used by law enforcement to recover stolen property" and solve crimes. If your stolen items are recovered you have a good chance of getting them back.

Bookmark Website Sites to keep informed on activity in our Area

To keep tabs of the latest crime throughout Omaha, please refer to crimemapping.com, a partnering agency site where Omaha Police Department crime reports are automatically sent on a daily basis. Enter your zip code and find your area. Also visit Douglas County site omahasher-iff.org/crimes-and-prevention/crime-map for updates on activity. Use the Omaha Mayors web site www.OmahaHotline.com to report any concern and/or see what reports have been submitted in our area or Omaha. Open the app and click on guest, then click on a subject matter, Vehicle/Parking Reports, then click on the upper right corner to see map location of reports, zoom in to our area for more detailed information and click on report.

Report, Share, Communicate

While the Omaha Police Department has seen an increase of some crime and/or suspicious activity reported within our patrol area. Please keep an open line of communication. Report, Share & Communicate – Also become a member of Nextdoor as this is a great tool for letting our neighbors know when something is happening. Sharing you information may help us solve a crime. Several households have security cameras or Ring Video Doorbell in the area. Working together as a neighborhood may help keep our area safer and catch the unwanted in the act.

Lien Process

There is a yearly \$100 fee for active liens. This is an effort to collect a debt or correct a violation. If a resident ignores our efforts to enforce the covenants we are duty bound to enact policies to encourage compliance.

Major appliances (washers, dryers, fridges, water heaters, etc.): take to designated appliance site (microwaves not included)

Tires & lead-acid batteries: take to designated tire site and lead-acid battery site

Yardwaste: take to desginated yardwaste site
