Greetings,

On behalf of the CHHOA Board of Directors I would like to extend a warm welcome to our new property owners. We do our best to maintain our



community and enforce our covenants equally and fairly to everyone. Our geographical locale is highly desirable and as a result, our homes sell very quickly. Recently, several homes in Cherry Hills sold for several thousand over asking price. That's a testament to our community and the value of having an active HOA.

Something very important that you should all be made aware of. Cherry Hills community is divided in three Phases – Phase 1, 2 and 3. Phase 1 covenants are due to expire on 4/17/21. The covenants will stay in effect for Phase 2 and 3 in perpetuity (do not expire). It takes 75% of the 215 lot owners in Phase 1 to amend the covenants so the expiration date of 4/17/21 can be changed to "in perpetuity" (same as Phase 2 and 3 covenants). After that date, it would require 100% of all lot owners in Phase 1 to reinstate. The Board of Directors is urging the Phase 1 homeowners to submit their ballot now showing that you are in favor of changing the expiration date of the covenants to be in accordance with Phase 2 and 3. Note: The Cherry Hills Home Owner Association will still continue to maintain our perimeter fence, entrances, signs and circles. Dues will still be applicable from all homeowners in Phase 1, 2 and 3.

We did not hold our 2020 Annual Members' Meeting and elections in May due to COVID19 lockdown and restrictions. The board voted unanimously to allow the Board of Directors' members whose terms were expiring to remain in their position until restrictions allow for safe meeting and elections. In 2021, if COVID continues to be an issue, we may experience continuing restrictions.

## **Friendly reminders:**

- Please store your trash cans out of sight of the street.
- Please pick up after your pet, especially when walking on sidewalks.
- Please be courteous to your neighbors when parking on the street.
- Avoid parking across from parked vehicles as this narrows the passage and an emergency vehicle often cannot pass between two parked cars.
- Keep the neighborhood looking nice for everyone.

We may have to take similar action as in 2020 until this challenging time is beyond us. The plan is to have an active and accountable HOA to be able to serve our members. We continue to have monthly Board of Directors' meetings via Zoom and alternative spots for meeting (as restrictions permit). We continue to respond to complaints and concerns of members as well as enforcing the covenants.

# Covenant's Corner

The covenant's committee has been busy, trying to upkeep the enforcement of the covenants.

Often it may seem like resolution is not happening in cases of violations, but the process takes time. After you notify us of a violation, it may take several months for the process to be completed.

In severe cases of a covenant violation, the board has tak-

en home owners to court to force compliance, and in every case so far, the board prevailed.

This is not always an enjoyable task, but one we are legally obligated to take on. Quite often people think we are 'picking on them', but we enforce all covenants fairly and equally.

We never police the neighborhood, all of our actions are based on neighbors calling in to report violations. If you see violations, please report them.

We have a variety of things we do to enforce the covenants. We al-

ways start with a friendly reminder letter, letting people know of the obligations of the covenants. We give ample time for residents to resolve the violation. If they refuse to comply, then we have no choice but to apply a lien.

Over the calendar year of 2020, we only had to apply 1 lien, so thanks to everyone for complying.

We do involve Omaha city code enforcement in many of our proceedings.

Please do your part to help keep our neighborhood looking nice.

#### Ground's Committee

The ground's committee is in charge of taking care of all of the common areas in the neighborhood, including the entrances. The fence line is formally inspected two times each year looking for damage or weak points. The goal is to have the fence repaired within 30 days, however, if major repair is required the response time is dependent upon the contractor's schedule. As always, please report damage or needed repairs to the Cherry Hills hotline as damage oftentimes occurs between inspections.

When walking the fence line for inspections, weed control and litter pick-up, the grounds chairperson has noticed a few home owners who have trees with branches that are beating against or resting on the fence. Please watch for this, and trim your trees. You could be held liable for damages for not trimming back trees, weeds, shrubs, et al.

Every few years the grounds committee bids out contracts for mowing, fertilizing, and tree maintenance. The association signs multiyear contracts in order to



receive discounts on service. Our current vendors are as follows: Fence Repair–Tom & Ron's repair, Mowing– Big Red Mowing, Fertilizing–Heartland Lawns, and Tree Care–Mutchie Tree Service. As a reminder, responsibility for snow removal has been transferred to the city. This has saved the association several hundred dollars in snow removal fees per year. For complaints on snow removal, you must now contact the mayor's hotline.

In 2020, the Grounds Committee completed the following projects:

- Several yards of mulch was added to the landscaped entrances.
- Weed and stump removal was conducted on the inner islands
- Mold/mildew on the Cherry Hills concrete signage at the 103rd and

105th Ida entrances was removed

- Eighteen gallons of weed control was sprayed along the fence lines and entrances
- All trees were trimmed along the entrances
- The Ida street parkway between 103rd and 105th street was cleared and mulch was added around the park bench
- Litter control was conducted along the fence line and entrances numerous times this year.

Thank you to all our volunteers who assisted in the following ways this year: 105th street entrance litter control and hosta planting; neighborhood fall clean-up day; and, periodic litter control. Your help is much appreciated this year. If interested in helping out in the future, please contact the hotline.

#### **OCCP Omaha Coalition of Citizens Patrol**

OCCP NW Tri "C" Citizens Patrol was able to purchase a new Dash Cam for use while we patrol. This is thanks to the support of area businesses, residences, and Omaha Police Officers Association. Should we ever encounter a situation where video needs to be shared with authorities, we now can provide. Early in November, we did witness an accident. Video was provided to all parties involved. The video should provide enough evidence as to whom was at fault.

OCCP is a nonprofit organization. All donations are tax deductible. Should any business or individuals wish to donate please contact me.

Through November, OCCP has Patrolled 561 miles. This was 55 hours of driving and an additional 41 hours walking patrol. These hours are from the volunteer effort of six members located in our neighborhoods.

**Please keep your vehicles locked and remove any valuables** to deter the criminals from breaking-in to your vehicle. If your vehicle is stolen, or broken-in to, please contact Law Enforcement immediately. Without record of the crime, there is no way to quantify the amount of police that needs to be present in our neighborhoods.
